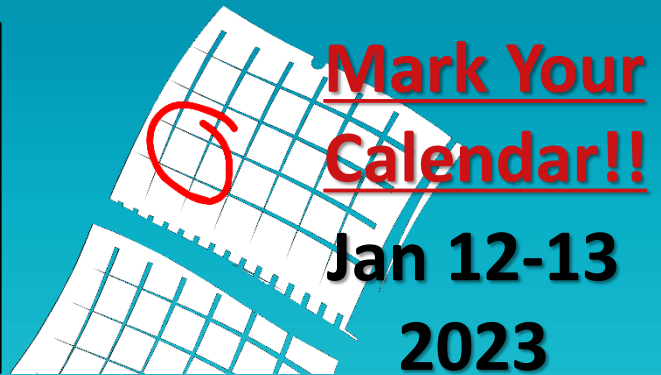

Do not miss this opportunity to create new business chances, find new business partners and expand your business.

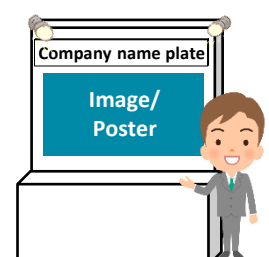


Browsing the exhibition

1 Show QR code to staff and read it by the staff's smartphone



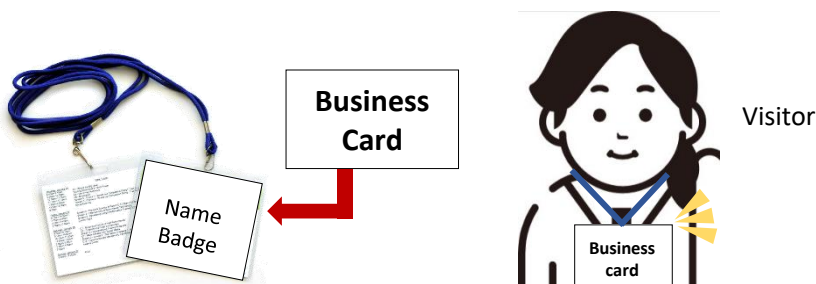
